

Fields Operating Hours: 7 am – 10 pm


Security: ACPS will manage campus security

Minnie Howard Campus Design








Vehicular Access


Project Budget and Cost Estimate

Aquatic Facility	\$18.5M	\$18.1M
Alexandria Health Department (Teen Wellness Center)	TBD	\$1.1M
Department of Community and Human Services (DCHS) Spaces	TBD	\$7.8M
